Amendments on Trans Fatty Acid Levels

Report Highlights:

The Government of India's (GOI) Food Safety and Standards Authority of India (FSSAI) amended the <u>Food Safety and Standards (Food Product Standards and Food Additives) Regulations, 2015</u>, to include maximum allowable limits for trans fatty acids.

Executive Summary:

FSSAI published the Food Safety and Standards (Food Product Standards and Food Additives) <u>Regulations, 2015</u>, and amended the maximum allowable limits of trans fatty acids in fats, oils, and fat emulsions. The amendments are based on feedback received following the public comment period from draft regulations published on November 11, 2014 (IN4114). (NOTE: although the most recent 2015 amendments are listed as officially published on August 4, 2015, there were not actually posted on FSSAI's website until August 27, 2015.) To date, the amended regulations have not been notified to the World Trade Organization (WTO).

Background:

On November 11, 2014, FSSAI notified draft Food Safety and Standards (Food Product Standards and Food Additives) Amendment Regulations, 2014. The amendment pertains to Chapter 2 of the Food Safety and Standards (Food Product Standards and Food Additives) Regulations, 2011, and includes updates to regulations 2.2.2, 2.2.5 and 2.2.6, which regulate standards relating to fats, oils and fat emulsions. A 60-day public comment period was established for these amendments, which expired on February 5, 2015. The most recent amendments take the public comment feedback into account.

A summary of amendments is given below.

- In sub-Regulation 2.2.2. relating to 'Interesterified vegetable fat', after clause (V) the following proviso shall be inserted:
 "Provided that maximum limit of trans fatty acids shall not be more than five percent by weight, on and from the 27th of August, 2016."
- 2. In sub-Regulation 2.2.5 relating to 'Margarine and fat spreads', after sub-clause (ii), the proviso shall be inserted:
 "Provided that the maximum limit of trans fatty acids shall not be more than five percent by weight, on and from the 27th of August, 2016."
- 3. In sub-Regulation 2.2.6 relating to 'Hydrogenated Vegetable Oils':
 - (i) In clause 1, sub-clause (vii), after item (b), the following proviso shall be inserted:
 "Provided that the maximum limit of trans fatty acids shall be not more than five percent by weight, on an from the 27th of August, 2016"
 - (ii) In clause 2, after sub-clause (a), the following proviso shall be inserted:
 "Provided that the maximum limit of trans fatty acids shall be not more than five percent by weight, on an from the 27th of August, 2016"

No. 4/15015/30/2011.—Whereas the draft of certain regulations to amend the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, were published as required under sub-section (1) of section 92 of the Food Safety and Standards Act, 2006 (34 of 2006), *vide* notification of the Food Safety and Standards Authority of India Number F.No 4/15015/30/2011, dated the 11th November, 2014 in the Gazette of India, Extraordinary, Part III, Section 4, inviting objections and suggestions from the persons likely to be affected thereby, before the expiry of the period of thirty days from the date on which the copies of the Official Gazette containing the said notification were made available to the public;

And whereas the copies of the said Gazette were made available to the public on the 5th December, 2014;

And whereas the objections and suggestions received from the public in respect of the said draft regulations have been considered by the Food Safety and Standards Authority of India;

Now, therefore, in exercise of the powers conferred by clause (e) of sub-section (2) of section 92 read with section 16 of the said Act, the Food Safety and Standards Authority of India hereby makes the following regulations

further to amend the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, namely:---

Regulations

- 1. These regulations may be called the Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2015.
- In the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, in regulation 2.2 relating to 'FATS, OILS AND FAT EMULSIONS', -
 - (a) in sub-regulation 2.2.2 relating to 'Interesterified vegetable fat', after clause (v), the following proviso shall be inserted, namely:-

"Provided that the maximum limit of trans fatty acids shall be not more than 5% by weight, on and from the 27th of August, 2016;";

(b) in sub-regulation 2.2.5 relating to 'MARGARINE AND FAT SPREADS', in clause 2 relating to "Bakery and Industrial Margarine", after sub-clause (ii), the following proviso shall be inserted, namely:-

"Provided that the maximum limit of trans fatty acids shall be not more than 5% by weight, on and from the 27th of August, 2016;";

- (c) in sub-regulation 2.2.6 relating to 'HYDROGENATED VEGETABLE OILS',-
 - (i) in clause 1, in sub-clause (vii) after item (b), the following proviso shall be inserted, namely:-

"Provided that the maximum limit of trans fatty acids shall be not more than 5% by weight, on and from the 27th of August, 2016;";

(ii) in clause (2), after sub-clause (a), the following proviso shall be inserted, namely:-

"Provided that the maximum limit of trans fatty acids shall be not more than 5% by weight, on and from the 27th of August, 2016;";
