### **Report Highlights:**

This report contains an unofficial translation of MinAg's Order prohibiting the import of poultry and poultry products from all countries with avian influenza. Tunisian imports of poultry and poultry products total \$10 million/year, including live chicks, meat, eggs, feathers, etc. The United States and Tunisia have agreed health certificates to better facilitate the trade of U.S. day-old chicks and hatching eggs with current trade valued at \$1 million/year. This measure has not been notified to the WTO.

Order of the Minister of Agriculture and the Environment dated 10 August 2011, prohibiting the importation or transit of all bird species and all categories of their products, produced or coming from countries contaminated by avian influenza

#### The Minister of Agriculture and the Environment,

Having regard to <u>Law No. 99-24</u> of March 9, 1999, on veterinary sanitary control of imports and exports, and in particular Article 18 thereof,

Having regard to the <u>Law n ° 95-2005</u> of October 18, 2005, relative to the breeding and the animal products, as modified by the <u>Law n ° 2007-54</u> of August 8th, 2007 relating to the fight against the doping in the sport,

Having regard to <u>Decree-Law No. 2011-14</u> of March 23, 2011, on the provisional organization of public authorities,

Having regard to <u>Decree No 2001-419</u> of February 13, 2001, laying down the powers of the Ministry of Agriculture,

Having regard to <u>Decree No. 2001-420</u> of February 13, 2001, on the organization of the Ministry of Agriculture, as amended and supplemented by <u>Decree No. 2010-625</u> of April 5, 2010,

Having regard to the <u>Decree No. 2009-2200</u> of July 14, 2009, fixing the nomenclature of the regulated animal diseases and enacting the general measures applicable to these diseases, as completed by the <u>Decree No. 2010-1207</u> of May 24th, 2010,

Having regard to Decree No. 2011-263 of March 10, 2011, appointing members of the Government,

Having regard to the <u>Order</u> of the Minister of Agriculture of May 19, 1999, establishing the measures to combat avian influenza,

In view of the opinion of the Minister of Public Health.

#### ORDER:

**Article 1** - A country in which at least one case of infection with avian influenza of domestic birds, raised or kept in captivity, is considered to be infected with avian influenza, in accordance with Article 1 of the Order of the Minister of Agriculture of May 19, 1999, referred above, and resumed its health status following a favorable end of the health event, and this, in accordance with the reports of the World Organization for Animal Health.

**Art. 2** - The import and transit of all bird species and all categories of their products, produced or coming from countries contaminated by avian influenza, are prohibited.

The import and transit ban does not apply to birds and products exported from a country before the first outbreak of avian influenza and arrived at the Tunisian border after the change in the health status of the exporting country.

**Art. 3** - Subject to the legislative and regulatory provisions in force and the second Article of this Order, the importation of the below is authorized:

- Fertilized eggs free from specified pathogenic microorganisms and intended for scientific and technical purposes.
- Products of birds produced or coming from countries infected with avian influenza and having undergone treatment in accordance with the provisions of the attached Annex and whose treatment method has been recorded in the veterinary health certificate accompanying the imported and approved consignment official veterinary services of the exporting country.
- Art. 4 This Order will be published in the Official Gazette of the Republic of Tunisia.
