#### **Report Highlights:**

FAS Manila maintains 2022 pork production at 1 million metric tons (MT), flat compared to 2021, as repopulation efforts in Luzon are offset by new outbreaks of African Swine Fever in Mindanao and the impact of Typhoon Odette (Rai) in the Visayas. Pork imports in 2022 also remain unchanged, as Most Favored Nation tariff reductions are scheduled to expire after May 17, 2022. The Philippine Tariff Commission is now reviewing an extension of the lower pork tariffs. Meanwhile, Post raises 2022 and 2021 chicken meat imports by 25,000 MT to 425,000 MT and 445,000 MT, respectively, based on year-to-date trade. Chicken meat production for 2022 is kept unchanged, while 2021 production is raised 13,000 MT to 1.343 million MT, in line with Philippine official data. No changes are made to Philippine beef production or imports.

### **Executive Summary**

FAS Manila maintains 2022 pork production at 1 million metric tons (MT), flat with 2021's level, due to the continued spread of African Swine Fever (ASF). New ASF outbreaks in Mindanao are expected to offset the repopulation efforts in Luzon. Moreover, Typhoon Odette (international name Rai) in December 2021 struck hog producers in the Visayas, which were beginning to boost production. Pork imports in 2022 are left unchanged at 375,000 MT, with the scheduled expiration of lower tariff rates after May 17, 2022, and expanded Minimum Access Volume already expired on February 1, 2022. Current efforts to lower prices by again reducing the Most Favored Nation tariff rate would facilitate higher volumes of pork. Post keeps 2022 chicken production at 1.36 million MT, in line with industry estimates that do not see Highly Pathogenic Avian Influenza (HPAI) affecting production. The Philippine Statistics Authority finalized 2021 chicken meat production at 1.343 million MT, 13,000 MT higher than the USDA Official projection. Meanwhile, Post raises 2022 chicken meat imports to 445,000 MT and 2021 imports to 425,000 MT, both 25,000 MT higher than the USDA Official, based on more shipments in 2021. HPAI outbreaks in Europe and North America, however, will constrain exportable supplies. Post keeps 2022 beef production unchanged at 190,000 MT because of limited land availability for expansion while maintaining 2022 imports at 230,000 MT, with lower-priced beef such as Indian carabeef supplying the meat processing sector.

Posts expects overall pork and poultry production to grow 2 percent in 2022, while overall energy is seen growing 4 percent during the same period. With growing cost considerations, feed millers are looking to other feed ingredients such as barley in place of feed wheat.

#### **Production**

Post maintains 2022 pork production at 1 million MT carcass weight equivalent (CWE), flat with 2021's level. New outbreaks of African Swine Fever (ASF) in Mindanao are expected to offset additional production from the hog repopulation efforts in Luzon. Producers remain hesitant to expand operations absent an ASF vaccine, while rising feed costs also provide headwinds. Moreover, on December 17, 2021, Super Typhoon Rai (local name Odette) swept through the central area of the Philippines, damaging hog facilities in Central and Western Visayas. These regions are free of ASF and were expected to be the drivers of pork production growth in 2022. According to industry contacts, issues ranged from damaged buildings, feed shortages (as feed mills were also damaged), limited fuel availability, and damaged roads.




Figure 2. African Swine Fever Zoning Status as of February 24, 2022




FIGURE 2. Map of the Philippines showing City / Municipality with no reported ASF case for  $\leq$  90 days (Red). 91 to 180 days (Blue) and  $\geq$  180 days (Grey).





# **Inventory**

Frozen pork inventory in accredited cold storage warehouses increased in 2001 and in the early part of 2022, reflecting the growing role of imported pork in meeting demand while domestic production remains limited due to African Swine Fever.





### **Prices**

After <u>pork tariffs were lowered in April 2021</u>, pig/pork prices declined through October 2021. Prices started to increase in November 2021 in response to growing demand during the holiday season and rising global prices. Meanwhile, the Philippine government has increased Suggested Retail Prices (SRPs) of luncheon meat and meat loaf have from August 29, 2021 to January 27, 2022.

#### Consumption

FAS Manila maintains 2022 pork consumption at 1.374 million MT, following no changes to production and imports. The pork MFN tariff rate is scheduled to expire on May 17, 2022, which will raise prices and constraint imports. However, the Philippine Tariff Commission held a <u>public hearing</u> on March 17, 2022, on extending the tariff rates until the end of 2022. If advanced by the Tariff Commission, the petition would next be reviewed by the National Economic and Development Authority (NEDA), the Department of Trade and Industry, the Committee on Tariff and Related Matters, and the NEDA Board, before going to the Office of the President.

The COVID-19 situation in the Philippines continues to improve. The National Capital Region is currently at Alert Level 1 (with movement restrictions significantly reduced or eliminated), with hotels, restaurants, and cafes allowed to operate at full capacity. International tourists from visa-free countries have been allowed to enter since February 10, 202 and further loosening of restrictions is expected.

#### **Trade**

Post maintains 2022 pork imports at 375,000 MT, in line with current trade flows and current Philippine trade policies. The increase in <u>pork Minimum Access Volume</u> (MAV) has already expired and MFN pork tariffs are scheduled to expire after May 17, 2022. Post also maintains 2021 imports at 460,000 MT based on year-to-date data. The pork MAV Plus, created by President Rodrigo R. Duterte's <u>Executive Order (EO) 133</u>, expired on January 31, 2022, alongside the end of the MAV calendar year 2021-2022.

On January 25, 2022, the Philippine Department of Agriculture issued <u>Administrative Order No. 2 (AO 2)</u>, re-extending the temporary 90-day validity of SPS Import Clearances for imported meat and poultry through December 31, 2022, due to the ongoing supply chain issues and logistical difficulties brought about by the global COVID situation.



#### **Production**


Post maintains 2022 chicken meat production at 1.36 million MT, up 1 percent from 2021's level. The Philippine Bureau of Animal Industry reported an outbreak of HPAI on January 6, 2022, in a duck farm in Baliuag, Bulacan. A second outbreak was reported on January 21, 2022, in two commercial quail farms in Candaba, Pampanga. And lastly, there was a third outbreak on January 27, 2022, also on a quail farm in Candaba, Pampanga. With no reported cases in broiler and layer farms, Post does not expect chicken meat production to be affected. Rising feed costs, however, will constrain additional growth.

FAS Manila revises 2021 chicken meat production to 1.34 million MT, 13,000 MT higher than USDA Official. This uses Philippine Statistics Authority final data for 2021 and results in 2021 posting 3 percent growth over 2020. Production still remains below pre-pandemic levels, when 2019 production reached 1.45 million MT.



# **Inventory**


Frozen chicken meat in accredited cold storage, which excludes mechanically deboned meat, has steadily declined since mid-2021 and is now below pre-pandemic levels.

#### **Prices**

Chicken prices started to increase sharply in February 2022, likely due to rising feed ingredient costs. The economy has also further reopened and this bodes well for hotels, restaurants, and institutions that sell chicken products but will also exert upward pressure on chicken prices.

#### Consumption

Post sees 2022 chicken consumption at 1.78 million MT, flat compared to 2021's level. Despite the further re-opening of the economy, supplies will be constrained due to local and international HPAI outbreaks.

#### **Trade**

FAS Manila raises 2022 chicken meat imports to 425,000 MT based on higher 2021 imports, which were raised from 420,000 MT to 445,000 MT due to year-to-date data. Exportable supplies to the Philippines remain limited because of the resurgence of HPAI and corresponding trade restrictions. Aside from the Netherlands and Poland, other EU countries that the Philippines issued bans include Spain, Hungary, Belgium, and Ireland. Following HPAI cases in North America, the Department of Agriculture's Bureau of Animal Industry (BAI) banned poultry exports from Nova Scotia, Canada on March 7, 2022. Moreover, DA-BAI stopped issuing Sanitary and Phytosanitary Import Clearances (SPSICs) of poultry from the United States and Canada for several weeks in February-March, 2022.






# **Production**

FAS Manila keeps unchanged 2022 and 2021 beef production at 190,000 MT and 180,000 MT, respectively. Cattle and carabao raisers remain constrained in increasing production due to limited land.

#### **Prices**

Farm gate prices for cattle backyard operations and beef retail prices in the National Capital Region (NCR) have been slightly increasing due to tight supply relative to demand. Similarly, the government raised the Suggested Retail Prices of corned beef and beef loaf on January 27, 2022.



# **Consumption**

Post keeps 2022 beef consumption unchanged at 419,000 MT, 4 percent higher than in 2021. As the economy opens further (and with the increasing population), demand for beef is expected to increase. Lower-priced beef and carabao (water buffalo) meat are generally used for meat processing, unlike higher-grade beef that is sold at retailers and food service establishments. The growth in beef consumption is driven by the lower-priced beef, as an affordable source of protein.

# **Trade**

FAS Manila maintains 2022 and 2021 beef imports at 230,000 MT and 225,000 MT, respectively, in line with overall increasing beef demand. The DA had placed import bans on <u>Canadian</u> and <u>German</u> beef due to bovine spongiform encephalopathy (BSE) atypical cases, with the DA lifting both restrictions in January 2022. The trade impacts, however, were minimal due to limited Philippine imports from both countries. The majority of beef and veal exports comes from Brazil and India, which are lower priced/grade and are used for meat processing. Due to the <u>September 2021</u> ban on Brazilian beef following an atypical BSE case, there was a noticeable decline in Brazilian beef exported in October 2021. Shipments have resumed since the Brazilian ban was lifted on <u>October 18</u>, 2021.
