VPSS Strengthens Border Quarantine Check

Report Highlights:

Russia strengthens its phytosanitary control at the border of the Customs Union in place of requiring Import Quarantine Permits and quarantine certificates.

General Information:

On August 12, 2011 (published on August 16, 2011), Russia's Federal Service for Veterinary and Phytosanitary Surveillance (VPSS) issued an instruction (No. FC-AC-3/10489) to the heads of its territorial offices, ordering its officers to conduct thorough phytosanitary checks on virtually all imported products of high phytosanitary risk and no less than 20 percent of imported products of low phytosanitary risk. Officials are instructed to increase checks proportionally to the rates of violations but also pay special attention to products originating from the European Union, Turkey, China, Egypt, Moldova and India.

The increased control will take place during the customs clearance process and effectively replace the import quarantine permit (IQP), which VPSS previously issued for imported products of high phytosanitary risk (Gain Report RS1140) and the quarantine certificate, which VPSS previously issued for products moving within the territory of the Russian Federation. According to industry, VPSS quarantine certificates were a serious and expensive obstacle for the internal movement of plants and products of plant origin.

Under the new control regime, VPSS' requirement to check virtually all products of plant origin defined as "high phytosanitary risk" demonstrates VPSS has confidence in neither (1) required phytosanitary certificates, issued by exporting countries nor (2) sampling methodology. As a result, these instructions are likely to place increased burden on the imports of plant-origin products into Russia as well as add to the cost of these imports. This instruction also means that Russia's, "one window" approach stipulated in the Russian Federal Law No. 394-FZ, which moved documents control and customs clearance to customs¹, will not be applicable for products of high phytosanitary risk.

The unofficial translation of the instruction follows in Appendix 1 to this report. Based on the required schemes of border control, FAS Moscow updated the Customs Union's list of products under phytosanitary control in Appendix 2 to this report.

Appendix 1. VPSS Instruction on Strengthening Check of Quarantine Products

Unofficial translation

Federal Service for Veterinary and Phytosanitary Surveillance (Rosselkhoznadzor - VPSS) Aug. 12, 2011 No. FC-AC-3/10489

To the Heads of Territorial Bodies of VPSS

The Federal Service for Veterinary and Phytosanitary Surveillance (VPSS) reports that in connection with the transfer of quarantine-phytosanitary control from the Russia-Kazakhstan and Russia-Belarus borders to the external border of the Customs Union, as well as the cancellation of quarantine certificate issuance for movement on the territory of the Russian Federation, the risk of damages to the Russian Federation's quarantine-phytosanitary security increases. This is connected with the hidden infestation of regulated products with quarantine objects and with their biological development during storage and transportation.

In this regard, in order to ensure the protection of plants and products of plant origin from quarantine objects on the territory of the Russian Federation, it is your personal responsibility to perform quarantine-phytosanitary control and laboratory analysis of quarantine products, included in the List [i] ... at the places of customs clearance, in accordance with the following scheme:

- 20% of imported lots included in group II of the List;
- 30% of imported lots included in the List under 0704, 080300, 0807, 110100, 1102, 4409;
- 50% of imported lots in the List under 070700, 0804, 1103;
- 100% of lots included in the List not mentioned above.

At the same time, in order to minimize the risk of penetration and the spread of dangerous pests on the territory of the Russian Federation, it is necessary to increase the percentage of lots subject to quarantine-phytosanitary control and laboratory analysis in proportion with the percentage increase of cases with detected quarantine pests. This shall be immediately notified to VPSS, attaching the justifications, by fax (499) 975 13 18 and by e-mail <u>fitoquarantine@mail.ru</u> with the subject "increase in % of control" and with a letter to follow.

In addition, the quarantine-phytosanitary control of imported products should be regulated using statistical data analysis on violations and the results of measures on ensuring quarantine-phytosanitary safety, undertaken by industrial unions and associations. These measures shall be confirmed by appropriate documents (results of preliminary control).

At the same time, based on statistical analysis of violations, we inform that when the quarantine-phytosanitary control is executed, special attention shall be paid to quarantine products imported from the countries – members of the EU, Turkey, China, Egypt, Moldova and India.
