We are pleased to inform you that FIEO is participating in the 2nd China International Import Expo at Shanghai, China from November 5-10, 2019. Details of participation in CIIE are as below:

Chinese President Xi Jinping inaugurated the 1st China International Import Expo (CIIE) in Shanghai from November 5-10, 2018 wherein more than 3,000 foreign companies from 172 countries around the world participated which offered them a platform to link up with potential buyers from the world's second biggest economy. With the world's largest population, China is the second largest economy, as well as the second largest importer and consumer in the world. Now China has entered a new development stage at which consumption keeps increasing, indicating enormous potential for the growth of consumption and import. In the next five years, China is expecting to import products and services valuing more than 10 trillion U.S. dollars, which provides a historic opportunity for enterprises across the world to enter the huge Chinese market.

1ST CIIE HIGHLIGHTS:

- According to the CIIE Bureau, which organized the event, the expo had over 4,00,000 domestic buyers, 6000 overseas buyers and more than 3600 exhibitors from 151 countries.
- Many high-profile leaders and top officials from across the world joined the event (the US being a notable exception), including some of the world's most successful entrepreneurs, such as Alibaba's Jack Ma, Microsoft's Bill Gates, and Xiaomi's Lei Jun.

At the closing of the six-day long event, the CIIE Bureau announced that deals worth a total of US\$57.8 billion had been secured. Of these deals, three industries stood out from the rest: the smart manufacturing industry (which represented almost a third of all deals at US\$16.5 billion), followed by food and agriculture (US\$12.7 billion), and the automotive industry (US\$12 billion).
