## EXAMINATION NOTIFICATION FOR THE DEPARTMENTAL EXAMINATION, 2022 FOR PROMOTION TO THE POST OF ASSISTANT GENERAL MANAGER (GROUP A, PAY LEVEL 10), <u>APEDA</u>

### 1. Schedule of Examination:

### 2. Eligibility Criteria:

As per the APEDA (Recruitment) Regulations 2022 as amended till 23.11.2022, 50% of the vacancies in the AGM cadre is to be filled by promotion through Departmental Examination. As per these rules, for promotion through Departmental Examination, officers holding the post of Manager with 5 years regular service in the post OR with 10 years combined regular service in the posts of Manager and Assistant Manager OR officers holding the post of Assistant Manager with 10 years regular service in the post are eligible to appear in the departmental examination. As per note appended there below, existing officers holding the post of Manager on the date of notification of the amendment regulations that is 23.11.2022, on completion of 3 years regular service in the post; OR 8 years combined regular service in the post of Assistant Manager on the date of notification of the amendment regulations that is 23.11.2022, on completion of 8 years regular service in the post are eligible for appearing the post of Assistant Manager on the date of notification of the amendment regulations that is 23.11.2022, on completion of 8 years regular service in the post are eligible for appearing in the departmental examination.

- Therefore, existing officers holding the posts of Manager with 3 years regular service in the post OR 8 years combined regular service in the posts of Manager and Assistant Manager; OR existing officers holding the post of Assistant Manager with 8 years regular service in the post, on the crucial date of eligibility, are eligible for appearing in the departmental examination.
- 3. Crucial Date of Eligibility:

The crucial date of eligibility shall be 01.01.2022.

4. Syllabus and Pattern of Examination:

The pattern and scheme of the examination is as follows:

A written test shall be conducted consisting of both objective type (multiple choice questions) and subjective type questions as under:

### 5. Medium of Examination:

The paper shall be bilingual i.e. Hindi and English. The candidate may choose to write the paper either in English or Hindi as per his/her choice. However, the candidates are expected to write answers in one language only (English or Hindi only).

#### 6. Qualifying Marks:

The test will be of qualifying nature. The qualifying marks will be as under:

- (i) For Scheduled Caste and Scheduled Tribe candidates 33%
- (ii) For other candidates 40%

Eligible candidates securing qualifying marks may be considered for preparation of the promotion lists, upto the number of vacancies in the promotion quota in respective categories, in the order of their seniority in their respective grades/posts. Promotion shall be made from these lists after obtaining approval of the competent authority.

The said lists will be valid for a period of one year from the date of declaration of results. The competent authority reserves the right to make promotions from the lists against subsequent vacancy/ies arising during the validity of the said list.

8. How to Apply and appear in the examination:

(i) Eligible applicants are required to apply through their official emails in the format prescribed at **Annexure**. The email containing the scanned copy of application should be sent to AGM (P&A) at the following email address only:

(ii) Email containing the scanned copy of application should be sent by the last date and time prescribed in para 1 of this notification. Only one application should be submitted by each applicant. Multiple applications or applications received after the last date and time shall be liable to be rejected. Original applications may be submitted to HoD(P&A) Division subsequently directly or in case of applicants working outside Delhi, by post. It is however brought to the notice of the candidates that the scanned copy of application sent by email will be considered as final for including their candidature, irrespective of receipt of original applications.

(iii) The list of candidates who have applied for the examination and whose candidature has been accepted provisionally for taking the examination will be available in the APEDA's official website www.apeda.gov.in under the heading "General Info" and selecting "Recruitments/Appointment" or typing/clicking the following link in the browser:

(iv) The applicants/candidates are required to be present in the Examination Hall sharp by 9.30 a.m. They are required to show their official ID Card in the examiner along with a self-attested of ID for verification. The copy of ID will be retained by the examiner for record.

(v) The examination will be held in Delhi. The applicants working outside Delhi will be eligible to claim TA/DA as per their entitlements.

9. Display of Result:

The lists of candidates who have qualified in the examination along with their marks will be displayed in the above mentioned website. Candidates who have not obtained requisite qualifying marks will also be displayed in the above mentioned website.

10. The candidates are required to submit an undertaking from the eligible candidates to the effect that they accept and agree to abide by the terms and conditions of the departmental examination.

11. All disputes arising out of the process shall fall under the jurisdiction of Delhi.
