2.1. With the objective of introducing the world to rich Indian food culture as well as promoting investments in the diverse food processing sector of the country, the Ministry of Food Processing Industries (MoFPI) launched the first edition of World Food India (WFI) in 2017. In view of celebrating 2023 as the International Year of Millets and to bring global food processing industry together, the Ministry of Food Processing Industries organized the second edition of WFI in 2023. This year, WFI 2024 will be organized from 19th to 22nd September 2024 in Bharat Mandapam at Pragati Maidan, New Delhi. - 4.5. No alcoholic beverages and room catering shall be permitted.
