CIRCULAR – IMPORTANT NOTICE TO EXPORTERS OF MANGOES TO JAPAN

SUBJECT : REQUISITION FOR STATIONING OF JAPANESE QUARANTINE INSPECTORS AT VHT FACILITY FOR EXPORT OF MANGOES TO JAPAN DURING 2013 MANGO SEASON

Dear sir/Madam,

This is with regard to the export of mangoes to Japan during the mango season 2013 which requires sufficient advance preparation. As you are aware, for monitoring of the Vapour Heat Treatment (VHT), Japanese Quarantine authorities place their own inspectors for the supervision of mango processing operation at each VHT facility in India. It is, therefore, requested to provide the details of your requirement in the standard format placed at **Annexure-1** so as to reach us by 15thDecember, 2012. Upon receipt of the information from your end we will be forwarding the same to the Japanese quarantine authorities for processing our request for deputation of the inspectors. The Japanese authorities need sufficient lead time for processing such requests. It may be noted that all the expenses on the positioning of the Japanese Quarantine Inspectors are to be borne by the VHT facility owner itself.

It may please be noted that once the requisition is placed, no change in schedule either for arrival or departure of the inspectors would be entertained since it has caused lot of embarrassment to the government of India in the last two years and the Japanese Quarantine authorities have indicated to us that such requests would not be entertained henceforth.

You are also requested to provide the information as detailed out in **Annexure-2** which would enable APEDA to expedite the matter with the Japanese authorities.

Based on the requisition received APEDA will, based on the past experience, estimate the expenditure and indicate to the applicants . the applicants would be required to remit the amounts so calculated in advance to APEDA and upon receipt of the same APEDA will forward the requirement of Inspectors to the Japanese authorities.

Kindly note that the VHT facility must necessarily make all tie ups with pack houses /growers etc for proper off take to justify the deputation of the Japanese Quarantine Inspectors.

Please note that as per protocol signed between the two countries, Japan accepts Vapour Heat Treated mango varieties – Alphonso, Kesar, Banganpalli, Langra, Chause and Malika only from the states of AP, Maharashtra, Gujarat, UP and West Bengal.

Kindly ensure that the complete information is submitted to APEDA within the stipulated time period as above.
