Rules and Regulations for Exporters

1) The exporters will have to submit the copy off APEDA registration document along with the form of booking.

2) Import Orders/consent letter of the importers

- 3) The booking will be considered only on First Come, First Serve basis.—on booking each exporter will be given one batch at a time. by rotation.
- 4) The rate for processing of mangoes in VHT machine will be minimum Rs. 12000/- per batch of 1.5 MTs/4 Hrs. The labour for handling of the mangoes at site will be arranged by the exporters.
- 5) The exporter will have to submit his demand in the prescribed format along with relevant documents **latest by 23/2/2007**
- 6) The allotted date & time slot will be communicated to the exporter, and accordingly he will have to pay 100% payment towards charges for processing well in advance (at least one week before)to MSAMB for final booking. All the payment should be made by Demand Draft in favour of "Maharashtra State Agricultural Marketing Board" payable at Pune.
- 7) Exporter has to produce thelab certificate for testing pesticide residues as per notification issued by Japanese Authorities available at Web site http://www.mhlw.go.jp/english/index.html
 - 8) If the mangoes for processing do not reach the VHT facility centre one hour in advance, the time slot will be allotted to the next exporter as per the rotation. No complaints will be entertained thereafter. The whole amount will be liable to be forfeited.
 - 9) Authorized representative of the exporter must be present at facility centre during the processing of mangoes.
 - 10) The facility of pre-cooling, cold storage, grading-packing line etc. available at the facility centre will be provided as per the availability. It will need separate booking at the facility centre.

11) Preference will be given for VHT processing of mangoes meant for international promotions purposes organized by APEDA.

12) The utmost care has been taken by MSAMB to keep the VHT machine in ideal condition. MSAMB will also not be responsible for any damages on account of processing, quarantine issues or any stoppages of the machine due to unavoidable circumstances.
